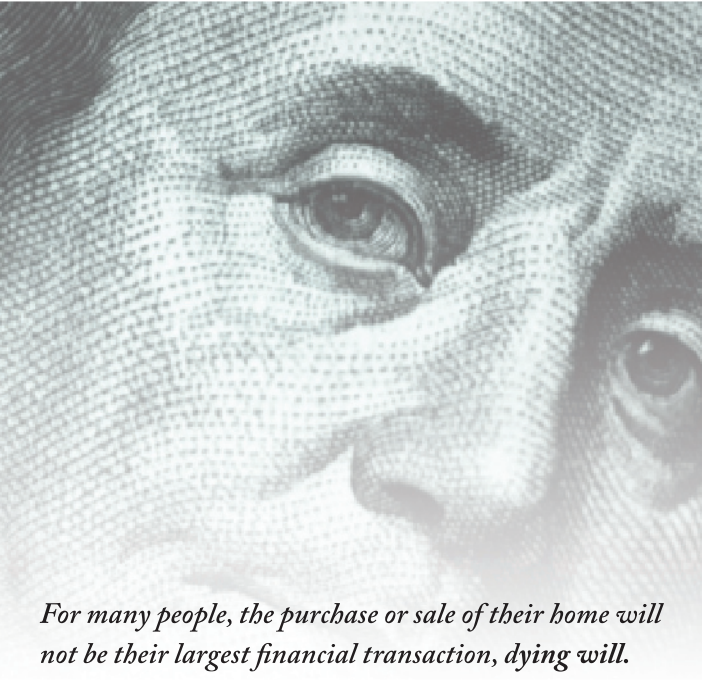

DURABLE POWER OF ATTORNEY

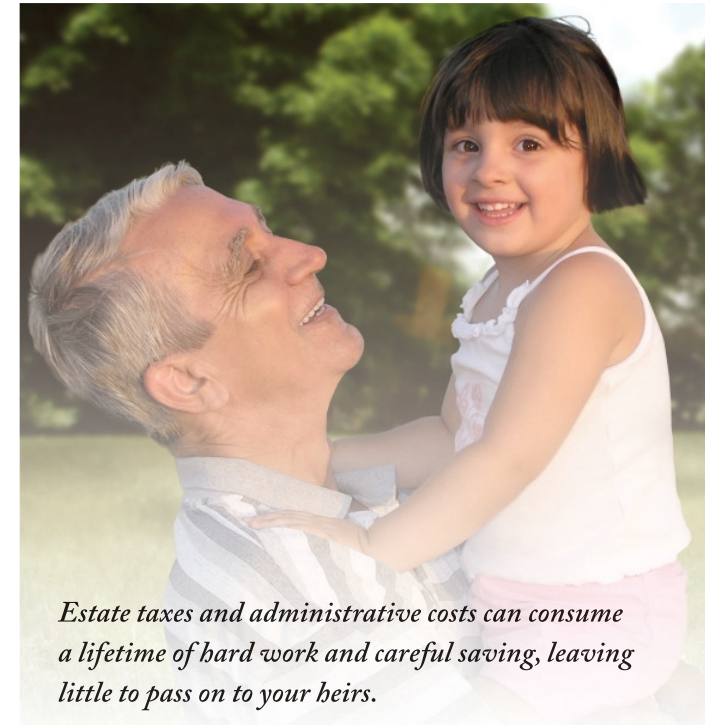
This enables another person to act on your behalf in managing your rights or assets during your lifetime.
